 Ninety five Acres, more or less, Reserving to myself and wife Mary Holcombe
 so much of said premises as will be necessary for our support during our natural
 lives Together with all the rights, Members, Hereditaments and appurtenances
 to the said premises belonging or in any wise incident or appertaining To have
 and to hold all and singular the premises before mentioned unto the said
 John Holcombe his heirs and assigns forever. And I do hereby bind myself
 my heirs Executors and Administrators to warrant and forever defend all and
 singular the said premises unto the said John Holcombe his heirs and assigns against
 myself my heirs and every other person lawfully claiming the same in any part
