One hundred and one dollars to me in hand paid by Solomon Walls of the State and District of said both bargain sold and conveyed and by these presents do grant bargain sell and convey unto Solomon Walls a certain tract a parcel of Land situated lying and being in the District and State of said on the head water of Mush Creek and bounded as follows My Beginning at a rock Stanton Post corner running thence N 37 W 16.30 chs to a stake in the road, thence with the road N. E. 46.25 chs to stake and Point two on the north line, thence N 35 E 4 chs to Post oak stump, thence E. 5 ch to a small branch thence down N. 45 E 6 chs to a bend thence S 80 E. 11.38 ch to a maple at the branch, thence S. 20 W 48 chs to a red oak, thence S 48 W 15 ch to the beginning, containing by estimation One hundred and one acres be the same more or less To have and to hold the above granted premises unto him the said Solomon Walls his heirs and assigns forever

To give them with all and singular the rights member here detaments and appurtenances therunto belonging in any wise incident a appurtenant and I the said Alfred Pool do hereby bind myself my heirs executors Administrators and assigns forever to him the said Solomon Walls his heirs and assigns a gainst myself my heirs and assigns and against any and every other person a persons lawfully claiming the same or any part thereof
