Southulter Lying on the waters of Peasee Dam creek north of North Saluda River the same being cut from the said Tract of Six hundred and nine Acres containing Five hundred Acres to the same now called Beginning Pine 34 0.22 Thence S 78° W 17.00 chains to Chesnut 34 0.22 Thence N 42° W 22.00 chs to Spanish oak 34 0.22 Thence N 50° E 55.10 chains to Pine Stake 34 0.22 Thence S 34° E 112.00 chains to Sassafras Stake 34 Thence S 30° W 111.30 chain to Stake 34 0.22 Thence N 33° W 6.00 chains to the beginning Pine 34
