

Testator Abraham Smith and she hereby release forever all interest which she may have in the same as the mother of her said daughter or as the wife or widow of Abraham Smith deceased. The Executor Thomas P. Brockman is to pay Sarah Holcombe with the consent of all the parties the sum of Thirty Dollars in full for her services in attending a young Glenn and a negro girl named Margaret the property of said Nancy Glenn during their last illness. W. S. Glenn the husband of Nancy Glenn deceased is to release the negro woman Mary and child and the interest on the Trust fund of about seven hundred Dollars in the hands of the Executor up to the first of January last and for and in consideration of the same, he releases and relinquishes forever all other claims and interest which he may in anywise have in the above legacies given to his wife by her father Abraham Smith.

The said Thomas P. Brockman Executor and Trustee as aforesaid is to proceed and sell and make titles to the Wood Tract of land above mentioned and specified in the said Will of Abraham Smith and the notes by check drawn by Nancy Glenn on a credit of Twelve months. The said Executor is likewise to receive the funds which will be in the hands of the Commission of Equity for the sale of the lands bought by James Locke and together with the remainder of the Trust funds and the proceeds of the sale of the Wood Tract of land and the by check, he will first pay the several sums above mentioned to Elizabeth Smith, Sarah Holcombe, W. S. Glenn, then pay all council fees which may be in reference to this matter and the drawing of this agreement and divide the remainder equally, commissions and charges being first deducted, between William Sheppard Joshua Smith and Stephen Smith share and share alike.

And we the undersigned do hereby agree and covenant with each other as above specified and we do bind ourselves jointly and severally our heirs Executors and administrators to faithfully keep the above covenant in all particulars and in order to carry out the same we do hereby renounce and release all other claims rights or interests which we may have in the premises.
