of the State and District aforesaid that by the authority vested in me by Elizabeth Smith Wm Glenn Stephen Smith Joshua Smith and William Shippard and Milly his wife which will more fully appear by a reference to a compromise entered into between the parties the 23rd day of February 1849 for the settlement of the property willed to Nancy Glenn died of her Father Abraham Smith, that for and in consideration to me in hand paid of the sum of Six Hundred Dollars paid by Josiah Kilgore Esquire of the State and District aforesaid I have bargained and sold and by these presents do grant bargain sell release and relinquish unto the said Josiah Kilgore, all that ^{one} parcel of land situated lying and being in the State and District aforesaid on Enoree River beginning at a Water mark 3x on the River corner running S 64th W to a stake 3x S W Snows corner thence N 10th E 3 near the branch 60.50 to a stake 3x Hickory cut down thence N 18th W 17.50 to a B.O 3x thence N 63th W 14 to an ash 3x W Greens land thence down the branch to Belt branch thence down said branch to Enoree River, thence down the meanders of the River to the beginning corner except half an acre opposite Brockmans Mill that was deeded for privilege of P. Weir to W. Green which will more fully appear by reference to the Plat containing Two Hundred and fifty and one half acres by a recent survey

Together with all and singular the rights members Hereditaments and appurtenances to the same belonging or in anywise incident

To Have and Hold all the aforesaid premises unto Josiah Kilgore his Heirs Executors Administrators and assigns for ever and I do hereby by authority as Agent, Warrants and former defend the same from myself and the aforesaid parties and from every person claiming the same in any part thereof
