 forty eight at the suit of J. Powell to me directed commanding me that of  
 the goods and chattels lands and tenements of Allen Potts to levy the sum of  
 thirty two dollar & 33 1/2 Cents damage and costs I have seized and taken of  
 the lands and tenements of the said Allen Potts all of his interest in all that  
 certain piece parcel and tract of land containing Three hundred acres situated  
 and being in the District of Greenville on the waters of Kedy River being the  
 Tract known Jonathan Potts now lies

And Whereas the said premises with the appurtenances since the seizure  
 by me made by virtue of the said Writ of Fieri Facias before mentioned have  
 been exposed to sale at public vendue and purchased by David Hoke of the  
 District of Greenville for the sum of Twenty One Dollars being the highest  
 sum bid for the same Now Know ye that I Messers Jaylor Sheriff of said  
 by virtue of the said Writ of Fieri Facias aforesaid to me directed and delivered  
 as aforesaid and by virtue of the Statute in such case made and provided and for  
 and in consideration of the said sum of Twenty One dollars to me in hand paid  
 or seemed to be paid by the said David Hoke the receipt and pay ment  
 whereof I do truly acknowledge have granted bargained and sold and by these pre-  
 sents do grant bargain and sell unto the said David Hoke his heirs and assign-  
 es forever the said tract piece and parcel of land with its appurtenances and all  
 the Estate right title and interest which the said Allen Potts of right had of  
 in or to the same To have and to hold the said piece parcel and tract of land  
 with its appurtenances unto the said David Hoke his heirs and assigns  
 forever as fully and absolutely as I the said Messers Jaylor Sheriff might  
 could or ought to grant bargain and sell the same by virtue of the Statute aforesaid
