 Acres more or less Bounded by lands of Oliver Barrett Joseph Chastine and Joseph
 McMillen and the river being a Tract of Land being a Tract of Land which Oliver
 Barrett purchased of the Ordinarys sale of the same for division amongst the
 four at law of Ours Dunahoo and recently in dispute in the Court of Common Pleas
 between the said Oliver Barrett and Jordan Poole under a purchase from Sally
 Poole Together with all and singular the Rights Members Hereditaments
 and Appurtenances to the said Premises belonging or in any wise incident or appur-
 taining To Have and to hold all and singular the premises before mentioned unto
 The said Oliver Barrett his Heirs and Assigns forever

And I do truly bind myself my Heirs Executors and Administrators to warrant and forever defend all and singular the said Premises unto
 the said Oliver Barrett his Heirs and Assigns against me and my Heirs
 and all others lawfully claiming or to claim the same or any part thereof
