Know all men by these presents That I Ovar Hecke of Greenville District in the State of said in consideration of Ten Hundred Dollars to me paid by John Adams of Greenville in the State of said have granted bargain sold and release and by these presents do grant bargain sell and release unto the said John Adams a certain piece parcel of Land Situated lying and being in the District and State of said on Huddy River Beginning on a Hickory corner on the original line on the West bank of Huddy River Thence running the original line S 50 W to a rock corner Thence running the original line N 40 W to a black Jack corner Thence running the original line N 80 E to Hugh Weards line Thence with said Weards line to said river Thence down said river to the beginning Together with all and singular the Rights, Members Hereditaments and Appurtenances to the said premises belonging or in any wise incident or appurtenant To have and to hold all and singular the premises before mentioned unto the said John Adams his heirs and assigns forever And I do hereby bind myself my heirs Executors and Administrators to warrant and forever defend all and singular the said premises unto the said John Adams his heirs and assigns against me and my heirs or any person or persons whomsoever lawfully claiming or to claim the same or any part thereof
