Whereas a writ of Summons to divide a well a certain Tract of Land herein
 described of the estate of Samuel Thompson of the State of Mississippi deceased
 issued from the Court of Ordinary of said District and upon the return thereof the
 Judge of said Court did determine that the said land could not be divided without
 injury to the interests of the parties and did order the same to be set off by the Sheriff of
 the District aforesaid on a credit of Twelve months Whereupon the Sheriff aforesaid
 did advertise the said Land for sale on the first Monday in June of the present year
 And whereas the Sheriff aforesaid did on the said day expose the said land at public outcry on
 the credit aforesaid the said Land when the said Wardlaw M. Bee was the last and highest
 bidder to whom the said Land was struck off for the sum of Eight hundred dollars
 Now this Indenture witnesseth that in consideration of the sum of eight hund-
 red dollars to me paid and secured to be paid I have granted, bargained, sold and
 released and by these presents do grant bargain sell and release unto the said Wardlaw
 M. Bee and his heirs and assigns forever all that Tract of Land situated in the
 District on the waters of Saluda River containing Two hundred acres it being
 part of a Tract of Land Originally granted to James Blasingame also the same tract
 of Land willed and devised by Joshua Thompson of said District deceased to the
 said Samuel Thompson and Surveyed and laid off to him in pursuance of the
 requisitions of said Will a description of which is represented by a plat hereunto
 annexed viz Beginning at a B. Oak 34 (now down) on original corner of S
