

Their future increase of said Slaves To Have and to Hold all and  
 singular The said Slaves and their increase aforesaid unto the said  
 W<sup>m</sup> Watson his Executors and administrators forever upon the special Trust  
 and consideration monthly and to and for the several uses intents and  
 purposes hereinafter mentioned and for some other purpose use and  
 intent whatever That is to say The Trust to permit and suffer the said Martha  
 D. Smith to have hold possess enjoy a full and the above named Slaves and their  
 increase aforesaid and to appropriate the proceeds thereof in any manner she may  
 think proper without the interference or contrivance of any person whatsoever and  
 without being liable in the present or future creditors of the said Benjamin  
 Smith or of those of any future husband in any manner whatsoever for  
 and during the Term of her natural life and at her death for the use and  
 benefit of such child or children as she may leave her surviving shall  
 and share alike if more than one child should she die without leaving  
 living <sup>her</sup> children and her said husband surviving the said negro slaves  
 and their increase shall revert to my estate and to be sold by the said  
 Trustee upon a reasonable credit and the proceeds to be distributed  
 between my legal representatives. Provided I should not be living but  
 should be living and should desire to distribute the said negro  
 slaves and their increase by a Will I reserve to myself the right to  
 do so and the distribution shall be in accordance with the will made  
 but should I die leaving no will then and in that case to be applied in  
 due course as before specified

It is not my desire that the said Trustee should  
 be put to any dollar expence or to any great trouble in the management  
 of said Trust he is therefore likewise empowered by this deed to pay all necessary  
 expences that he may incur in the discharge of his duty as Trustee aforesaid  
 out of the proceeds of the labor of the said Slaves and the labor of their increase  
 and he is at liberty to retain the usual commissions in the event of his having  
 to sell the said slaves on the happening of the contingency above specified  
 which authorises a sale

Provided however should it so happen that it should  
 become necessary to change the property in consequence of the said Slaves and  
 their increase becoming a burden and unprofitable and inadequate for the  
 support of my said daughter Martha D. Smith and her child or chil-  
 dren then and in that case the said Trustee with the acquiescence of my said  
 daughter Martha D. Smith to give out or sell one or more of said Slaves and their  
 and invest said proceeds in the most judicious manner for her support and  
 I do fully authorize the said Trustee by the consent of my said daughter  
 Martha D. Smith to manage the said Slaves and their increase in any  
 manner that will be to the greatest advantage for the support and maintenance  
 of my said daughter Martha D. Smith and her children should the said Trustee  
 and my daughter Martha D. Smith deem it expedient to change a course  
 the proceeds of the sale of said Slaves and their increase in lands it is fully  
 authorized by this deed but let it be distinctly understood that should any  
 change in said Slaves be made by the said Trustee the present or any future  
 husband of my said daughter Martha shall have no contrivance or management  
 therein shall the same be liable for the present or future debts or contracts of any
