 parcel of land situate in said District on Hammetts Branch Bluff of North  
 Tyger River Greens Creek of South Packet River containing Two Hundred  
 & three Acres more or less Beginning at a Stake at the Single Road near the  
 mouth of a branch Thence with the meanders of the Branch S 18 1/2 W 7 1/2  
 to a Stake on the branch Thence S 76 W 3 1/2 to a rock Thence S 46  
 40 chains to back line Spanish Oak 37 3/4 Thence with the back line S  
 18 W 15 ch to chest 34 Thence S 83 W 15.00 Stake 37 Thence S 14 1/2 E 25.00  
 chest 34 Thence S 17 1/2 E 5.00 Ch. 0 3/4 Thence S 3 E 45.00 Stake a rock  
 S 34 E 30.75 Ch. 0 3/4 down on the Single Road Thence with said road
