Know all men by these presents That, Mary Glenn of Greenville District and State of South Carolina for and in consideration of Five hundred Dollars to me paid by Moses M. Gray of Greenville District in the State of South Carolina have granted, bargained, sold, aliened, released and by these presents do Grant, bargain, sell and release unto the said Moses M. Gray a certain lot of land lying in the village of Greenville State of South Carolina being part of a lot conveyed to me by John Powell beginning at a stake at the lower end of the lot owned by John McMillan Thence down Church Street to the corner of Avenue and Church Street Thence along Avenue Street Three hundred feet to the corner of Avenue Street and the street dividing said lot from Rachel Johnson's lot and now owned by John W. Walker Thence up said Street one hundred and thirty four feet to a Rock John J. McMillan corner Thence along John McMillan's line to the beginning corner

Together with all and singular the rights members, hereditaments and appurtenances to the said premises belonging or in any wise incident or appurtenanting To have and to hold all and singular the premises before mentioned unto the said Moses M. Gray his heirs and assigns forever And I do hereby bind myself my heirs Executors and administrators to warrant and forever defend all and singular the said premises unto the said Moses M. Gray his heirs and assigns against me and my heirs and any persons whomsoever lawfully claiming or to claim the same or any part thereof
