

Dollars with the condition that they will not go without the limits of the State of South Carolina without leave of said court and that they will appear and abide stand to and perform the sentence order and decree of the said court in the premises and whereas James Mc Ashmon James M McDaniel Alexander Mc Bee and Jordan P Poole have become the sureties of the said Sarah Wells and Carter Wells in the said Bond to the Commissioner in Equity as aforesaid and whereas the said Sarah Wells and Carter Wells are desirous of indemnifying and saving harmless their said sureties from and against all loss or damage by reason of their suretyship as aforesaid Now know all men by these presents that we Sarah Wells and Carter Wells aforesaid in consideration of and in pursuance of the premises aforesaid and for the better securing of the said James Mc Ashmon James M McDaniel Alexander Mc Bee and Jordan P Poole from loss or damage by reason of their suretyship for us as aforesaid and also in consideration of the sum of Ten dollars to us paid by the said James Mc Ashmon James M McDaniel Alexander Mc Bee and Jordan P Poole we have bargained and sold and by these presents do bargain and sell to the said James Mc Ashmon James M McDaniel Alexander Mc Bee and Jordan P Poole the following named twelve Slaves *viz* Charles aged twenty three years Van aged twenty years Adam aged sixteen years James aged thirty three years Caroline aged nine years Victory aged seven years Elizabeth aged four years Mary aged thirty five years Francis aged fourteen years Phillis aged twenty five years and her two children Eleanor and Maria and in plain and open market deliver the said Slaves to the said James Mc Ashmon James M McDaniel Alexander Mc Bee and Jordan P Poole To have and to hold the said twelve Slaves unto the said James Mc Ashmon James M McDaniel Alexander Mc Bee and Jordan P Poole their Executors Administrators and assigns forever Provided always nevertheless that if the said Sarah Wells and Carter Wells their Executors and administrators shall and do well and truly indemnify and save harmless the said James Mc Ashmon James M McDaniel Alexander Mc Bee and Jordan P Poole from all loss injury or damage which might in any wise accrue to them by reason of their suretyship aforesaid according to the true intent and meaning of these presents then this deed of bargain and sale and all and every clause article and thing therein contained shall cease determine and be utterly void and of none effect and thing herein before contained to the contrary thereof in any wise notwithstanding And it is hereby declared by and between the said parties and the said Sarah Wells and Carter Wells for themselves their heirs Executors and administrators do covenant promise and agree to and with the said James Mc Ashmon James M McDaniel Alexander Mc Bee and Jordan P Poole that until the said James Mc Ashmon James M McDaniel Alexander Mc Bee and Jordan P Poole shall be fully and entirely released and discharged from any and all manner of liability to loss injury and damage by reason of their suretyship as aforesaid it shall and may be lawful to and for the said James Mc Ashmon James M McDaniel Alexander Mc Bee and Jordan P Poole their Executors Administrators agents Attorneys or assigns from time to time

and at any time hereafter peaceably and quietly to enter unto any or all the messuages lands or tenements of the said Sarah Wells and Carter Wells and to take the said twelve Slaves into their own custody and possession and the same to hold and detain to their own use and behoof as their own proper goods and Chattles from thenceforth and forever or the same to sell and dispose of at pleasure returning the overplus after endeavoring themselves as aforesaid unto the said Sarah Wells and Carter Wells their Executors Administrators or assigns In Witness whereof we have hereunto set our hands and seals this sixth day of October in the year of our Lord One thousand eight hundred and fifty seven and in the 82nd year of the Independence of the United States of America

John I Smith of the State and District aforesaid for and in consideration of the sum of Five hundred and thirty seven dollars to me in hand paid by Henry Mc Smith of the State and District aforesaid the receipt whereof I do hereby acknowledge have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Henry Mc Smith all that Tract or parcel of Land on both sides of Brushy Creek waters of Enore River containing Two hundred and six acres more or less in the said State and District Beginning on Red Oak 3+ 0m on the Car bank Road thence S 2 1/2 E 12.36 chains to a white Oak 3+ 0m in the fork of the Branch by the Ten Nat thence S 43 W 26.20 chains to Hickory 3+ 0m thence S 55 W 15.50 chains to Hickory 3+ 0m thence S 4 W 30.00 chains to Red oak Sapling 3+ 0m on thence S 75 E 12.50 chains to Rock 3+ 0m on thence S 33 E 1.50 chains to Red Oak 3+ 0m thence S 29 E 22.50 chains to Rock 3+ 0m on thence S 60 E 44.00 chains to Pine 3+ 0m on the old car Bank Road thence along the different meanderings of said Road to the beginning Red Oak 3+ 0m Together with all and singular the rights members hereditaments and appertaining therunto belonging or in any wise incident or appertaining To have and To hold all and singular the premises before mentioned unto the said Henry Mc Smith his heirs and assigns forever and I do hereby bind my self my heirs Executors and administrators to warrant and forever defend the above
