third day of June, in the year of our Lord, one thousand, eight  
hundred & fifty eight, and due two months after date for three  
hundred dollars, he is and by the said sealed Note (Relation being  
thereunto had,) doth more fully and at large appear.

Now know ye, that the said Mrs J. Bates for the better se-  
curing the payment of the said sum above mentioned, unto the  
said Char. J. Hill, his Executors, Administrators or Assigns, together  
or with lawful interest for the same, have bargained and sold  
and by these presents doth bargain, and sell, and in plain and  
open Market deliver unto the said Char. J. Hill, My Photograph Cam-  
era, and the stock of Chemicals, Cases, & Frames. I have now in  
hand. To have and to hold, the said mentioned articles, unto  
the said Char. J. Hill, his Executors, Administrators & Assigns forever.  
Provided Always Nevertheless, that if the said Mrs J. Bates, heirs  
Executors, and Administrators, shall and do, well and truly pay  
or cause to be paid unto the said Char. J. Hill, his certain Attorney  
Executors, Administrators, or Assigns, the full and just sum above men-  
tioned, according to the true intent, and meaning of the said sealed  
Note aforesaid, and of these presents, then this deed of Bargain  
and sale, and all and every clause, Article, and thing therein  
contained, shall cease, determine, and be utterly void, and of no effect

anything before herein contained to the contrary thereof, in anywise not  
withstanding. And it is hereby declared by and between the parties  
and the said Mrs J. Bates for himself, his Executors, Administrators  
and assigns doth covenant, promise and agree to, and with the said  
Charles J. Hill his Executor, Administrator and assigns, by these pre-  
sents, that if default shall happen to be made off, or in payment of  
the said sum above mentioned, according to the true intent and mean-  
ing of the said sealed Note, that then, and in such case, it shall  
and may be lawful to and for the said Char. J. Hill, his Executors,  
Administrators, Assigns, Attorneys, or Agents from time to time, and at  
any times hereafter, peaceably and quietly, to enter into any or all the  
Meadows, lands, or tenements of the said Mrs J. Bates, and to take  
into his custody and possession, and the same to hold and detain  
to his own use and behoof, as his own proper goods and chattels,  
from thenceforth and forever, or the same to sell, and dispose of,  
at his will and pleasure; returning the oversplus, if any should
