W Morrison since bargaining & selling my Slaves to Jourdau P Pool & Benjamin H Perry in order to pay my debts & secure the remainder of the purchase money to myself hereafter have ascertained that the debts will greatly exceed the sum of Twenty Five thousand dollars, and whenas it becomes necessary to make a change in my contract with the said Pool & Perry in relation to the aforesaid trade. Now know all men by these presents that in consideration of the further sum of Fifteen thousand dollars in cash paid me by the said Jourdau P Pool & Benjamin H Perry the receipt whereof I do hereby acknowledge I have bargained sold & delivered & by these presents do bargain sell and deliver all my right title & interest in the said fifteen Slaves Jack Sophrona Jerry Mary & her infant child Henry Andy Betsey Nancy John Morrison Saniza Pinck Sam Ritta & Butler with the future increase of the female Slaves, and do warrant & forever defend all & singular my right title and interest in the said Slaves and the said Slaves themselves & their future increase unto the said Jourdau P Pool & Benjamin H Perry their heirs executors administrators and assigns against me my heirs executors administrators and all persons claiming the same. And I do hereby authorize the said Jourdau P Pool & the said Benjamin H Perry to let the said Slaves remain in the possession of my wife during her life time & then to take possession of them, and in further consideration of the said sum of Fifteen thousand dollars paid me as aforesaid, I have released the annuity of three thousand dollars which was to have been paid me & also reduced the Bond of the said Pool & Perry to the sum of Two thousand dollars which together with the sum of four thousand dollars in cash paid me makes six thousand dollars for the said Slaves, besides two hundred dollars otherwise paid me

that in pursuance of directions and authority to me for that purpose given in and by the last will and Testament of Abraham Cox deceased I David Hooker as Executor of the said last will and Testament of Greenville District in the State aforesaid for and in consideration of the sum of One thousand dollars to me in hand paid by James Lenderman of Greenville District and State aforesaid have granted bargained sold and released and by these presents do grant bargained sell and release unto James Lenderman, all that piece parcel and tract of land situate lying and being in the District of Greenville and State aforesaid on Reddy Fork waters of Reddy River being the tract of Land whereon Abraham Cox lived and died containing Two hundred and forty six acres, more or less and bounded as follows beginning on a Maple thence S 57th W 22.50 to P. O. 3rd then S 67th W 21st ch B O 3rd thence S 67th E 37th chs Rock 3rd P O gone thence N 64th W 44th ch Hickory 3rd thence N 68th E 22.50 Rock at Reddy Fork creek thence up the Creek to Maple 3rd thence S 9th W 1.90 chs Rock thence N 74th W 34th 75 ch Rock 3rd thence S 55th W 2.67 chs Rock 3rd thence N 64th W 4.60 ch Maple the beginning corner Bounded by lands of W Lenderman and James Cox of Cleveland and John Ashmore and James Lenderman together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. So have and to hold all and singular the premises before mentioned unto the said James Lenderman his heirs and assigns forever. And I do hereby bind myself my heirs Administrators Executors, so far as I am Executor of the will of Abraham Cox deceased and no further, to warrant and forever defend, as Executor of the will of Abraham Cox deceased, all and singular the said premises unto, James Lenderman his heirs and assigns against me and my heirs and against the heirs of Abraham Cox deceased and any other person or persons whomsoever claiming or to claim the same or any part thereof. Witness my hand and seal this third day of September in the year of our Lord one thousand
