Now this indenture witnesseth that the said Samuel Green for and in consideration of the said debt or sum ^{payable} as aforesaid to the said William Mc Thomas Commissioner as aforesaid and for the better securing the payment thereof to the said William Mc Thomas Commissioner as aforesaid according to the bond aforesaid and also in consideration of the sum of three dollars by him the said William Mc Thomas Commissioner as aforesaid to the said Samuel Green in hand paid at and before the sealing and delivery of these presents do grant bargain sell alien release convey and confirm unto the said Wm Mc Thomas and to his successors in office forever all that tract of land situate in Greenville District in the State above named on waters of Brush Creek waters of Enoree River containing forty six and one half acres more or less adjoining lands of Hop Holtzclaw Hains and estate of Hains commencing on the Creek at a stake 3x3x n m N 13.33 to a stake 3x3x n m N 70 1/2 28.40 to a stake 3x3x n S 55 1/2 610.30 to a stake 3x3x o m on the Creek up said Creek to the beginning corner Together with all and singular the rights members and appurtenances thereto or in any wise appertaining and the reversions and remainders rents issues and profits thereof To Have and to hold the said Land with the appurtenances unto the said William Mc Thomas and his successors in office forever. Provided always nevertheless and it is the true intent and meaning of the parties to these presents that if the said Samuel Green and his heirs executors or administrators shall well and truly pay or cause to be paid unto the said William Mc Thomas his successors in office or assigns the sum of four hundred dollars according to the bond above mentioned then and from thenceforth these presents shall be utterly null and void anything herein contained to the contrary thereof in anywise notwithstanding and it is covenanted and agreed upon by and between the parties to these presents that until default shall be made in payment of the aforesaid sum as before set forth and the interest for the same it shall and may be lawful to and for the said Samuel Green peaceably and quietly to hold use occupy possess and enjoy all and singular the premises above granted and released and every part thereof with the appurtenances and to have receive and take the rents issues and profits thereof to his own particular use and behoof anything herein contained to the contrary hereof in anywise notwithstanding.
