of the District of Greenville and in the aforesaid State in consideration of the sum of sixteen hundred Dollars to me in hand paid by James Lenderman of the District of Greenville in the State aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said James Lenderman all that piece parcel or Tract of Land Situate in the State and District aforesaid on the Mile Branch waters of Kedy River containing ninety and three fourth acres be the same more or less, beginning at Hickory 3x3x0m thence N 5 1/2 E 12,65 chs to Rock 3x3x0m thence N 21 1/4 E 40,30 ch to Small Post oak 3x3x0m thence S 48 1/2 W 14,50 to Maple 3x3x0m thence S 8 W 4,08 chs to Red Oak 3x3x0m thence S 83 3/4 W 11,13 ch to Pine 3x3x0m thence S 22 W 27,05 ch to Rock 3x0m in place of a Red Oak 3x0m gone thence S 20 W 4,26 chains to Rock 3x0m thence S 48 E 17,25 chains to the beginning Hickory 3x which will more fully appear by a plat thence unto annexed made by W J Threlkild Dept Surveyor the 30 October A D 1857
