Viz; beginning on a white oak corner near the River thence South to a hickory corner thence N E to a pine not corner thence N to a white oak corner at the Swamp thence S West to a pine corner on S<sup>d</sup> Swamp thence up the edge of S<sup>d</sup> Swamp to the beginning corner containing fifty acres more or less. Together with all & singular the rights members hereditaments & appurtenances to the same belonging or in any wise incident. To have and to hold all the premises to the only use of him the said William R Green his heirs assigns administrators &c for ever and I do hereby bind myself my heirs & administrators for ever to defend the or any part thereof Given under my hand & Seal this the 25<sup>th</sup> day of January A.D. 1861
