 B Turnbull of the city of Charleston in the State afore
 said have granted bargained sold and released and by
 these presents do grant bargain sell and release unto the
 said Anna B Turnbull, all that piece parcel and lot of
 Land lying being and situated in the Town of Greenville and
 State aforesaid in the north East portion of said Town
 having the following hettings and boundings, Viz, Begining
 on a Stake near the old Baptist Church on Avenue Street
 running thence N 74 W 100 feet or half the whole lot to a
 Stake, thence N 16 E 170 feet to a Stake thence S 74 E 100 feet
 to a Stake, thence S 16 W 170 feet to the begining being the
 Lot purchased by me from the Estate of D Long decd dated
 in February 1860, Together with all and singular the rights
 members hereditaments and appurtenances to the said
 premises belonging or in any wise incident or appertain
 ing, So have and to hold all and singular the premises before
 mentioned unto the said Mrs Anna B Turnbull her heirs and
 assigns forever and I do hereby bind my self my heirs executors
 and administrators to warrant and forever defend all and singular
 the said premises unto the said Mrs Anna B Turnbull her heirs
 and assigns against me and my heirs and all persons or
 persons lawfully claiming or to claim the same or any part thereof

 year of our Lord one thousand eight hundred and Sixty two and
 in the 86th year of the sovereignty and Independence of the State
