 of the road running from J Mc Protwell to Andrew Adams running
 S 27 1/4 E 37.10 chs to a Stake on the edge of the road running from Double
 Spring Meeting house by said Carltons + Sandy Goodlitts, thence
 S 65 W 11.82 chs to a P.O 3+ now thence N 6 1/2 W 33.15 chs to the beginning
 corner Together with all the rights members hereditaments and
 appurtenances to the said premises belonging or in anywise incident or
 appertaining to have and to hold all and singular the premises before
 mentioned unto Blake Carlton him his heirs and assigns forever
 and I do bind myself my heirs executors and administrators to warrant
 and forever defend all and singular the said premises unto the said
 Blake Carlton his heirs and assigns against myself my heirs and assigns
 and against every other person or persons whomsoever lawfully claiming
