Whereas on the \_\_\_\_\_ day of July  
AD 1862 James McRandal et al filed their bill of complaint  
in the Court of Equity for Greenville District of the State aforesaid  
against Cicero Randall et al for the partition of certain Real  
and personal property in which Harriet McRandal had a life  
estate under the will of Elizabeth Greer of Spartanburg District  
and the same having been heard at chambers on the \_\_\_\_\_ day of  
October AD 1862 the Honourable Court did then order and decree  
that said Land should be sold at public auction after three  
weeks public notice of the sale published in a newspaper and  
the said Land having been duly advertised, on the fourth  
day of November AD 1862 was publicly exposed for sale on the  
premises by William McThomas Esqr Commissioner of the said  
Court of Equity and sold to George W Lester of the District  
and State aforesaid he being the highest bidder for the same  
at Eight Hundred and One dollars, and Whereas the said  
George W Lester then and there as above stated did not  
purchase said Tract of Land for himself alone but for William  
& Lester Archibald Mc Lester and George W Lester as copartners  
in Manufacturing at Buena Vista in the District and State  
aforesaid, and whereas it is meet and proper just and  
right that said Tract of Land should now be conveyed in  
fee simple to the said William F Lester Archibald Mc Lester  
and George W Lester as copartners as aforesaid to be held  
and owned by them as copartners as aforesaid share and  
share alike. Now therefore know all men by these presents  
that I George W Lester of the District and State aforesaid  
in consideration of the facts above stated have granted  
bargained sold and released and by these presents do grant  
bargain sell and release unto the said William F Lester  
Archibald Mc Lester and George W Lester as copartners as  
aforesaid and to be held and owned by them as copartners  
ship property all that tract or parcel of Land situate lying  
and being in Greenville District about eleven miles from  
Greenville Court House adjoining Lands of Bates Green and  
others containing ninety three and one half acres more or less  
beginning at a stake on the Augusta Road J H Green corner  
88 1/2 W 19.66 to a persimmon 37 N 20 E 11.28 to a stake 31.87 S W  
23.00 to a stone on old line 3 N 32 W to Heally on line thence down  
meanders of Heally Branch to a poplar 37 S 66 E 28.00 to stake on
