bargained sold and released and by these presents do grant bargain
sell and release unto the said James Mc Ashmun all that
certain piece parcel and tract of Land lying and being
in Greenville District and State aforesaid on the head
waters of Nuddy fork adjoining Lands of J J Farmer and
E Bramlett and others beginning at a Stake 3+ on the road
leading to McBees Factory, thence S 3 W 22.90 chs to a black
gum 3+ near McKenzies road thence N 39 W 480 chs to a stake 3+
thence S 63 W 1.07 to a stake 3+ on the aforesaid road thence N 63 W on
said road 13.40 chs to stake at the place the Factory road crosses
near J J Farmer residence thence along the Factory road N 32 E
4.50 chs to a stake at bend of road thence N 57 E 8 chs to a stake at
another bend of road thence N 60 E 6 chs to bend of Road thence
N 67 E 3.30 to the beginning corner containing Twenty and one half
acres more or less, together with all and singular the rights, man-
-ners hereditaments and appurtenances to the said premises belonging
or in any wise incident or appertaining, to have and to hold all and
singular the premises before mentioned unto the said James Mc Ashmun
his heirs and assigns forever, and I do hereby bind my self
my heirs executors and administrators to warrant and forever
defend all and singular the said premises unto the said James
