Know all men by these pres-
 ents that I Richard Ross of the District and State afo-
 said for and in consideration of the sum of six hundred & sixty
 five Dollars to me in hand paid by Miller Ross of the
 same State and District have granted bargained sold
 and released and by these presents do grant bargain
 sell and release all that tract or plantation of land
 situate in the District and State above mentioned on branch
 waters of brushy Creek of Enoree River containing one hund-
 red and thirty five acres more or less beginning on a stake by
 Augusta Road thence up said road N 35 1/2 W 24.12 to a stake
 bend in Road thence N 28 1/2 W 16.20 to a stake 34 n thence from
 said stake by road S 44 W 8.00 to a stake 34 0 thence N 53 W 20.00 to
 P. O 34 n thence S 50 W 27.44 to a W O 34 thence S 41 3/4 E 40.78 to a R. O
 34 0 thence N 31 E 24.72 to a P O 34 0 thence S 58 1/2 E 27.50 to B O 34 0
 thence N 6 1/2 E 1.64 to the beginning corner. Together with all
 and singular the rights members hereditaments and apper-
 tenances to the said premises belonging, or in any wise
 incident or appertaining. To have and to hold all and
 singular the premises before mentioned unto the said
 Miller Ross his heirs and assigns forever, and I do hereby
 bind my self my heirs executors and administrators to
 warrant and forever defend all and singular the
 premises before mentioned mentioned unto the said Miller
 Ross his heirs and assigns against my self my heirs and
 against every other person lawfully claiming or to claim
 any part thereof.
