 ents that I William Hunt of Greenville District in the  
 State aforesaid in consideration of the sum of Five thousand  
 Seven hundred and fifty Seven Dollars and cents to me in  
 hand paid by Lardner Gibbon of the State and District above  
 mentioned. Have granted bargained sold and released and  
 by these presents do grant bargain sell and release unto  
 the said Lardner Gibbon all that piece parcel or tract of  
 Land situate lying and being in Greenville District and  
 State aforesaid. On the East Side of Saluda River containing  
 Six Hundred and Six acres be the same more or less  
 beginning at White Oak 3+3+0 m on the bank of said River  
 thence N 61 $\frac{1}{4}$  E 2.00 chs to Hickory 3+3+ Thence S 84 $\frac{1}{4}$  E 55.15 chs  
 to Rock 3+3+0 m thence N 13 $\frac{3}{4}$  W 10.35 chs to Small white oak 3+4  
 Rock 3+ each, thence N 71 $\frac{1}{4}$  E 15.20 chs to Rock 3+3+0 m thence N 33 $\frac{3}{4}$   
 W 27.90 chains to dogwood 3+ near branch thence N 44 $\frac{1}{2}$  E 34.42 chs to  
 Red oak 3+3+0 m on the Road leading from said Hunt to Green-  
 ville Court House thence N 84 $\frac{1}{2}$  E along said Road to the White  
 Horse Road 5.28 chs to Rock on said Road 3+ thence along said  
 White Horse Road N 1 E 17.64 chs to bend in said Road thence  
 N 9 $\frac{1}{4}$  E along said Road 19.75 chs to Red oak 3+0 m cut down  
 on the west side of said White Horse Road on Bayles Farms

 Bear Church Tract, thence S 32 E 3.35 chs to Rock 3+0 m in  
 the Road leading from Greenville Court House to Pickens  
 Court House, thence S 49 $\frac{3}{4}$  W 9.45 chs to Spanish Oak 3+ near  
 Spring of the said Bear Church thence N 56 W 1.16 chs to  
 White oak 3+ near the Spring, on Frances Groves line thence  
 with said line S 40 $\frac{1}{4}$  W 48.80 chs to rock 3+0 m on branch thence  
 thence down the meanders of said branch to a Pascumion 3+  
 0 m on said branch thence N 4 $\frac{1}{4}$  W 17.25 chs to Rock 3+ in old  
 field thence N 89 $\frac{3}{4}$  W 16.20 chs to Red oak 3+3+0 m thence N 60 $\frac{1}{2}$
