G W Center	Deed	South Carolina Know all men by Greenville District that G W Center of the State & District above named for & in consideration of nine hundred Dollars to me in hand paid by Catharine Heart of the State & District aforesaid he has granted bargained sold & released & by these presents do grant bargain sell & release unto the said Catharine Heart two tracts or parcels of Land in the State & District aforesaid on Green Creek waters of South Paolet the first containing One thousand Seventy acres more or less & runs as follows (to) beginning on a W O 3+ near John A Butlers Spring thence S 48 W 16.50 to a chestnut 3+ S 11 E 45.00 to a stake 3+ on the South line of McLemurs Survey N 64 E 55.50 to a stake 3+ N 35 W 50.00 to the beginning 3+ the other tract adjoining the above & containing thirty three acres more or less bounded on the South end by the first tract on the west by S Center Land on the S side by Mathew Ballews Land on the East by W Parrishs and John Peace Land both tracts being bounded by lands of G W Center Stephen Center Mathew Ballew W Parrish John Peace & A Butler. Together with all and singular the rights members hereditaments and appurtenances to the same belonging or in anywise incident or appertaining. To have & to hold all and singular the premises before mentioned unto the said Catharine Heart her heirs and assigns forever and I do hereby bind myself my heirs executors and administrators to warrant and forever defend the same unto the said Catharine Heart & her heirs against myself my heirs executors and administrators for ever. In witness whereof I have hereunto set my hand & seal this the 14 th day of August 1863 And the Eighty seventh year of the Independence of the State of South Carolina.
