Know all men by these presents that I Greenlee Smith of the District and State aforesaid for and in consideration of the sum of three thousand and fifty five dollars to me in hand paid by Joel Rector of the district and State aforesaid the receipt whereof I do hereby acknowledge have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Joel Rector all that tract or parcel of Land situate lying and being in the district and State aforesaid on the head waters of Peters Creek waters of Enore River adjoining lands of W P Vaughn the estate of David Vaughn deer fence plots and others beginning at the branch on a black gum 3+3+0 m thence along said branch to a black gum 3+3+0 m thence N 43 1/2 E 90 links to a black gum 3+3+0 m thence N 39 1/2 W 22.23 chains to a stake 3+0 m thence N 31 1/2 E 9.00 chains to a Chesnut 3+3+0 m down, thence S 66 1/2 W 23.11 chains to a Red Oak 3+3+0 m down, thence S 75 1/2 E 90 chs to a Rock 3+0 m thence S 8 W 5.30 chains (Bend, S 15 W 4.76 chs, Bend, S 10 W 5 ch, Bend, S 8 W 7.86 ch, Road, to Greenville Small Post oak 3+3+0 m Road to Sloc Austin N 41 E 1.31 chs stake 3+3+0 m S 81 1/2 E 11.96 ch to a Black gum the beginning corner, containing seventy acres the same being more or less, together with all and singular the rights members hereditaments and appurtenances to the same belonging or in anywise incident or appertaining, to have and to hold all and singular the premises before mentioned unto the said Joel Rector his heirs and assigns forever and I do hereby bind myself my heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said Joel Rector his heirs and assigns, against myself and my heirs and against every other person whomsoever lawfully claiming or to claim the same or any part thereof In witness whereof I have hereunto set my hand and seal this 12<sup>th</sup> day of December in the year of our Lord one thousand eight hundred and sixty one, signed sealed & delivered in the presence of
