 by David Long of Greenville District in the State aforesaid
 have granted bargained sold and released and by these
 presents do grant bargain sell and release unto the said
 David Long all that piece parcel and lot of land situate
 lying and being in the Town of Greenville and District and
 State aforesaid and bounded as follows, Viz, beginning at a
 stake being the S.W. corner of James Goodlett's Lot on the Ruther-
 ford Road, and running thence One hundred and forty feet
 S 2 E with said road to a stone being the S.W. corner of a lot
 sold by us to N. & S. G. Craft, thence N 87 E Three hundred and
 eighty four feet with said N. & S. G. Craft's line to a stake on
 said David Long's line thence S 3. W One hundred and forty
 feet with said David Long's line to a stake being said James Goodlett's
 S E corner thence S 87 W Three hundred and eighty four feet
 with said Goodlett's line to the beginning being Lot No 7, in
 the plan of lots on the Rutherford Road belonging to Estate
 of Edward Craft Deceased as set forth in a plat hereto annexed
 together with all and singular the rights, Members
 Hereditaments and appurtenances to the said premises
