Now this inden- ture witnesseth that the said Gasham Ross for and in consideration of the premises aforesaid and also in consideration of the sum of five dollars to the said Gasham Ross by the said Michael D Dickey in hand paid at and before the sealing and delivery of these presents have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Michael D Dickey all that tract of parcel of land containing sixty five acres more or less situated lying and being in the District and State aforesaid lying on a branch water of South Carolina river adjoining lands of J Ramsey Bowden Dr W A Mooney and James Barnwell being a tract of land deeded to me by Charrow Barton Jr bearing date the 27 th day of April 1863 beginning at the big road leading through Gowensville to Spartanburg S. C. on the lower line of said tract and running with said line to P.
