 for the payment of the full and just sum of One thousand Dollars  
 within three months after date with interest from date and dated  
 the fourth day of December eighteen hundred and sixty five  
 being for a tract of land purchased by the said Ann Marshall  
 at the estate sale of William L. Marshall deceased for the sum  
 of One thousand Dollars as is and by the said bond and  
 condition thereof being hereunto had well known fully appear  
 Now know all men that I the said Ann Marshall in con-  
 sideration of the said debt and sum of money aforesaid and for the  
 better securing the payment thereof to the said Robt McKay  
 Ordinary his successors in office or assigns according to  
 condition of the said bond and also in consideration of the further  
 sum of three dollars to me by the said Robt McKay Ordinary  
 of Greenville District in hand well and truly paid by the said  
 Robt McKay Ordinary at and before the sealing and delivery  
 of these presents the receipt whereof is hereby acknowledged  
 have granted bargained sold and released and by these presents  
 do grant bargain sell and release unto the said Robt McKay  
 ordinary of Greenville District his successor in office or  
 assigns all that tract of land situated in Greenville District  
 on waters of Rabun's creek bounded by lands of R. Peter E. Nash  
 Jordan Nash and others and containing One hundred and one  
 half acres more or less being the same tract of land purchased  
 by me at the estate sale of William L. Marshall deceased for  
 the sum of One thousand Dollars due three months after  
 date with interest from date refering to the deed made  
 to me by Robt McKay Ordinary this day well known fully  
 appear together with all and singular the rights thereto

hereditaments and appurtenances to the said premises belonging  
 or in anywise incident or appertaining to have and to hold all and  
 singular the said premises unto the said Robt McKay ordinary his  
 successors in office or assigns his heirs and assigns forever and  
 I do hereby bind my self my heirs executors and administrators to  
 warrant and forever defend all and singular the said premises  
 unto the said Robt McKay his successors in office his heirs and  
 assigns from and against me and my heirs executors administra-  
 tors and assigns or any person whatsoever lawfully claiming or  
 to claim the same or any part thereof. Provided always never-  
 theless and it is the true intent and meaning of the parties to  
 these presents that if I the said Ann Marshall do and shall will  
 and truly pay or cause to be paid unto the said Robt McKay  
 ordinary of Greenville District his successors in office or assigns  
 the said debt or sum of money aforesaid with the interest thereon  
 if any shall be due according to the true intent and meaning of  
 the said bond and condition thereunder written then this deed  
 of bargain and sale shall cease determine and be utterly null and  
 void otherwise it shall remain in full force and virtue and it is  
 agreed by and between the said parties that Ann Marshall is  
 to hold and enjoy the said premises until default of payment
