the other part Thomas Williams Sr & John Shockley et al by their next  
friends J. W. Cook on or about the first day of September in the year  
of our Lord one thousand eight hundred and sixty two exhibited  
their bill of Complaint in the Court of Equity at Greenville Court House  
in the said State against John Shockley Administrator for the sale  
of the lands of Thomas Shockley deceased And the cause being  
at issue before the Honorable Court came on to be heard at Chambers  
in the year of our Lord one thousand eight hundred and sixty two  
when the said Court after full hearing thereof and mature deliber-  
ations in the premises did order Adjudge and decree that said land  
should be sold at Public Auction by the Commissioner of the said  
Court on the terms and for the purpose mentioned in their Reported  
Order as by reference thereto in the Registry of the said Court will ap-  
pear And the said Wm M Thomas as Commissioner of the said  
Court after having duly advertised the said land for sale by Public  
Auction on the Saturday of October in the year of our Lord one thou-  
sand eight hundred and sixty two did then openly and
