A B Hunt to James A Taylor

The State of South Carolina Greenville District This Indenture made the eighteenth day of August in the year of our Lord one thousand eight hundred and sixty eight between A B Hunt of the State and District aforesaid of the one part and James A Taylor of the same State and District of the other part Witnesseth That as the said A B Hunt is indebted unto the said James A Taylor in the sum of five thousand five hundred dollars and interest by sealed Note bearing even date with these presents payable one day after date with the interest from date Now this Indenture Witnesseth That the said A B Hunt for and in consideration of the sum of five dollars to the said A B Hunt by the said James A Taylor in hand paid at and before the sealing and delivery of these presents have granted bargain sold and released unto the said James A Taylor all that piece parcel and tract of Land situate lying and being in Greenville District South Carolina or parts of same known as the Hills Place adjoining the lands of

James Monrovia Taylor Rowleson and others and containing three hundred and two acres and three fourths of an acre more or less being the same tract conveyed by Moses Fowler to Dr Francis A Miles by deed of November the fifth in the year of our Lord one thousand eight hundred and fifty seven and by the said Miles to the aforesaid Taylor by deed of November the seventh in the year of our Lord one thousand eight hundred and sixty three and by the said Taylor to the said Hunt by deed bearing even date with these presents together with all and singular the Rights Members Hereditaments and Appurtenances to the said Premises belonging or in any wise incident or appertaining To have and to hold all and singular the Premises before mentioned unto the said James A Taylor his heirs and assigns forever And I do hereby bind myself my heirs Executors and Administrators to warrant and forever defend all and singular the said Premises unto the said James A Taylor his heirs and assigns against me and my heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof Provided Always Nevertheless that if the true intent and meaning of the parties to these presents that if the said A B Hunt his heirs Executors or Administrators shall will and truly pay or cause to be paid unto the said James A Taylor the sum of five thousand five hundred dollars according to the tenor and effect of the Note above mentioned then and from thenceforth these presents shall be utterly null and void; anything herein contained to the contrary thereof in any wise notwithstanding; And it is covenanted and agreed upon by and between the parties to these presents that no default shall be made in payment of the aforesaid sum as before set forth and the interest for the same shall and may be lawful to and for the said A B Hunt Peaceably and quietly to hold use occupy possess and enjoy all and singular the Premises above granted and released and every part thereof with the appurtenances and to have received and take the rents issues and profits thereof to his own particular use and behoof of any thing herein contained to the contrary hereof in any wise notwithstanding; I do witness whereof the said parties have hereunto set their hands and seals the day and year first above written The words all and that was erased after the signing sealed and delivered in the presence of J^r P^r Moon A B Hunt (Seal) J^r A Taylor (Seal) J^r P^r Moon W^r A^r McDaniel (Seal) J^r P^r Moon
