Huller and was conveyed to Zion Hooley by Oliver Barnett W. H.
Taylor Atty. Together with all and singular the rights members
hereditaments and appurtenances to the said premises belonging
or in anywise incident or appertaining. To have and to hold all
and singular the premises before mentioned unto the said Letty
Hooley her heirs and assigns forever and I do hereby bind myself
my heirs executors and administrators to warrant and forever
defend all and singular the rights members hereditaments and
appurtenances to said premises belonging or in anywise incident
or appertaining To have and to hold all and singular the premises
before mentioned unto the said Letty Hooley her heirs and assigns
forever and I do hereby bind myself my heirs executors & administrators

Court of Probate of said County by Jane Fowler praying that
a certain tract or parcel of land hereinafter described of her
husband's estate be sold and the proceeds of the sale invested
in other property for her sole use and benefit and Andrew
Forrester Trustee of the said Jane Fowler consenting to and
recommending the sale and investment on terms agreed upon
On due examination of the said petition and prayer the
Judge of said Court did order and Decree that the said land
be vested in the said David Adams at one hundred and forty
four dollars, on his paying the said sum into the said Court
Now this indenture witnesseth that in consideration of the
sum of One hundred and forty dollars to me paid I have granted
bargained sold and released and by these presents do grant
bargain sell and release unto the said David Adams and his

a settlement road to a stone thence S 63 W 7.60 to the beginning stone
corner bounded by lands of Jacob Keyde Israel McAdrip and
others and containing forty acres more or less. Together with all

title interest claim or demand which the said Jane Fowler
had in or to the same. To have and to hold the said tract of land
together with all and singular the premises improvements and
