Donald as aforesaid a Lien for the amount which shall be so advanced with the interest thereon at the rate of 7 per centum per annum on all the crops of whatsoever description he may grow or cause to be grown during the year aforesaid on the farm or plantation of the said N. W. Garrison in the County and State aforesaid in accordance with the act of the General Assembly of the State of South Carolina entitled an act to be more advances for agricultural purposes passed the twentieth day of September in the year of our Lord one thousand eight hundred and sixty five And it is agreed by and between the parties as aforesaid by their presents that the said N. W. Garrison for himself his executors administrators and assigns does hereby consent to promise and agree to and with the said J. F.
