Know all men by these presents that Alexander McBees of Greenville County in the State aforesaid in consideration of the sum of Two Hundred and Ninety Eight Dollars and forty six Cts to me paid by Alex P Mills of Greenville County in the State aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Alex P Mills a certain tract of land situate in the County of Greenville and State aforesaid about two and a half miles from the City on the Grove Road Beginning on a Stone in the Edge of said Grove Road Mills Corner of another tract, and runs thence N 47 3/4 W 78 feet with Mills other line to a Stake near a small Branch Run or now Peatles Corner thence N 77 3/4 W 99 feet with Peatles line to a Stone in old field thence S 43 1/2 E thirty two feet to a Stone on said Grove Road Charles Corner thence up said Road N 24 E seven Chs 88 feet to the Deeds Stake containing by survey and Plat of W D Threlkeld 16 Acres more or less. Together with all and singular the rights Members hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining.
