 by the beginning corner and estimated to contain
 five acres said land having been all
 deeded by Wm. Waters to Richard Harrison and having
 been sold as the property of Edward Dill by Samuel L.
 Donahit Probate Judge to John Pinkney Dill and by him
 conveyed to his wife Caroline Dill about three years ago
