I W T Shumate Assignee of Stephen Marchbanks of Socumville
in said State Bankrupt, send greeting; whereas, the said Stephen
Marchbanks was upon the day of A D 18
adjudged a Bankrupt, upon his petition, by the District
Court of the United States, for the District of South Carolina,
and whereas, the rest and residue of his estate (embracing the
lands hereinafter mentioned and conveyed) was by operation
of Law vested in me, the said W T Shumate his duly appointed
assignee, And whereas, I, the said W T Shumate Assignee
as aforesaid in obedience to an order of sale to me directed
by the District Court of the United States for the District of
South Carolina, did upon the fifth day of June A D 1846
proceed to sell at public auction, the lands hereinafter mention-
ed and conveyed, being a part of the Estate of the said Stephen
Marchbanks Bankrupt, which lands were duly purchased by
Whitner Symmes he being the highest bidder at the said
sale, Now therefore, this indenture witnesseth, that I the said
W T Shumate Assignee as aforesaid, for and in consideration
of the sum of One thousand and twenty five Dollars, to
me in hand paid, the receipt whereof is hereby acknowledged
have granted, bargained sold and released and by these presents
do grant bargain sell and release unto the said Whitner
Symmes all and singular my right, title, interest and Estate
of, in, and to all that certain piece parcel and tract of land
situate lying and being in the County and State aforesaid partly
by Paris Mountain adjoining lands of Dr J P Hollenizer
Samuel Stradley, William Pise, Robert Whitnise E W
Howard, Henry Jacobs, Caroline Heavens, S S March-
banks W E Carle and others, containing Seven hundred
Acres more or less, and known as the Heavens tract place
of Stephen Marchbanks Bankrupt, Together with all and
singular the rights members hereditaments and appurtenan-
ces whatsoever, to the said premises belonging, or in
anywise incident or appertaining, and the reversions
and remainders rents issues and profits thereof, and also
the Estate, right, title interest claim possession property
claim and demand whatsoever, both at Law and in
Equity, of the said Stephen Marchbanks and of all other
persons rightfully claiming or to claim the same or
any part thereof, so far as Assignee I have the right
to do, To have and to hold the said tract of land with its heredi-
taments privileges and appurtenances, unto the said Whitner
Symmes his heirs and assigns and to his and their own prop-
er use benefit and behoof forever,
