Wells partners under the firm name of Earle & Wells in the State of South Carolina (the receipt whereof is hereby acknowledged) have granted, bargained, sold, released and by these presents do grant, bargain, sell and release unto the said Thomas L. Gover, W. J. Shumate, W. A. Hudson, J. T. Steele and E. B. Dickson and to the said Earle & Wells all that piece parcel and lot of land situate, lying and being on the corner of Washington and Laurens Streets in the City of Murrells South Carolina, having the following lines, metes and boundaries viz: Beginning at an Iron Pin on the corner of Laurens and Washington Streets and running thence S 19° 30' W 105.7 to a stake on Laurens Street thence with J.
