Alexander M Taylor, Susan E Noel, Eliza J Noel and Lucinda M Taylor Guardian for William B Taylor of Newville County in the aforesaid State for and in consideration of Five hundred Dollars to us in hand paid by P. B. Taylor of Greenville County in the State aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said P. B. Taylor all our undivided interest in the following described tract of land it being one sixth part interest for each of us and is part of a tract of land conveyed to us by James McIlhenny the 9th day of August A. D. 1859 known as the Barton tract containing Ninety one (91) acres more or less lying and being situate in Newville County and State aforesaid and the West side of Barton's Creek of South Tyger River and runs as follows beginning at a stake 3x in the center of the bridge across Barton's Creek thence N 42 1/2 W 22.00 chains to a stake 3x chestnut gone thence N 54 1/2 E 11.00 chains to a stone 3x near the road thence N 10 E 16.80 chains to a stake 3x 3x in an old road thence N 57 1/2 E 20.95 chains to a Red Oak 3x W. P. Bates and B. J. Dill's corner thence S 42 1/2 E 17.83 chains to a stake 3x in the center of Barton's Creek (of Tyger River) thence down and with the meanderings of said Creek 50.58 chains to the beginning bounded by lands of W. P. Bates, B. J. Dill, D. H. Noel, P. B. Taylor, R. K. Kampton and A. M. Taylor.
