E Church South in the State aforesaid (the receipt whereof is hereby acknowledged) have granted bargained sold and released and by these presents do grant bargain sell and release unto the said W A Jennings W H Ashmore S T Mears P A M David and J W Austin Trustees aforesaid and their Successors in office the following piece or tract of land situated in Greenville County and State aforesaid containing six acres three Rods and thirty four Poles more or less for the use of the Methodist Episcopal Church South beginning at Stone thence running N 3 1/2 W 12.00 to Stone thence S 81 1/2 W 5.60 to Pine thence S 68 W 2.34 to Red Oak thence S 15 1/4 E 7.30 to Stone thence S 63 1/4 E 7.17 to the beginning and bounded by lands of Estate of Charles Terry Sullivan Manufacturing Company and P D Curston as exhibited by Plat and Survey of P D Houff Acquit 10th 1877 Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining. To have and to hold all and singular the said premises before mentioned unto the said Trustees and their Successors in office forever and we do hereby warrant and forever defend all and singular the said premises unto the said Trustees and their Successors in office against us and our Successors in office lawfully claiming or to claim the same or any part thereof.
