

a trust deed, that a suitable trust deed be reported, together with some suitable person or persons to act as trustee or trustees; and whereas upon the said cause being heard on the 17<sup>th</sup> day of June A.D. 1874, it was referred to a special Referee, to report on the various matters embraced in the pleadings in said cause, and upon the report of said special Referee coming in, containing the various recommendations therein more fully set forth, it was on the 7<sup>th</sup> day of August A.D. 1874, amongst other things, ordered that Whitson, Symmes and Thomas Le Gower, be appointed Trustees, to whom William A. McDaniel, Clerk of the said Court, should convey the said lands, to have and to hold the same, to, for and upon the purposes, uses and trusts, as set forth and declared in the deeds reported, by the said Referee; and whereas, the said William A. McDaniel, Clerk as aforesaid, did convey the lands mentioned in the pleadings to the said Trustees;

Now therefore, Know all men by these presents, that we, Thomas Le Gower and Whitson Symmes Trustees as aforesaid, by virtue of the power conferred upon us, in and by the order and trust deed aforesaid, upon the written request of the cestui que trust hereunder, and in performance of our duty as such Trustees and also in consideration of the sum of Two Hundred Dollars, to us paid by Frank A. Williamson before the delivery of these presents, have granted, bargained, sold and released and by these presents do grant bargain sell and release unto the said Frank A. Williamson all that piece, parcel or lot of land being parcels of the lands above mentioned - situate and lying in the City of Breckinridge County and State aforesaid commencing at a stake on the N. E. corner of Williamson lot remaining between North West four chains to a stake at the right of way City and Railway, thence along said Right of way S. 4 E. four chains and fifty links to stake, thence N. 54 7/8 E. two chains and eighty seven links to the beginning containing six tenths of one acre or more and more fully represented by Plat of James 19<sup>th</sup> May 1875 by Geo. P. Johnson Surveyor together with whatever right title and interest we may have by virtue of deed from W. A. McDaniel Clerk to us or of us and to the right of way contiguous to said lot of land Together with all and singular the rights members hereditaments and appurtenances, to the said premises belonging, or in anywise incident or appertaining. To have and to hold, all and singular the premises before mentioned, unto the said Frank A. Williamson, his heirs and assigns forever freed from and discharged of all further trusts whatever, and we do hereby bind ourselves, our heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said Frank A. Williamson, his heirs and assigns against us, and our heirs and every other person, whomsoever lawfully claiming, or to claim the same, or any part thereof by, through and under us, as trustees aforesaid, Witness our hands and seals this eleventh day of March in the year of our Lord one thousand eight hundred and seventy eight and in the one hundred and second year of the
