Greenville County in the State aforesaid (the receipt whereof is hereby  
acknowledged) have granted bargained, sold, and released and  
by these presents do grant, bargain, sell and release unto the said  
M S De Camps all that lot or parcel of land, lying and being  
in the State aforesaid, County of Greenville and in the N E part  
of the City of Greenville beginning at a stake corner, being  
the S W corner of said lot thence N 21 1/2 E 5.47 chs to stake  
corner then on a street, thence S 68 E 1.71 chs to a stake corner on  
thence S 17 W 5.50 chs to stake corner on, thence N 68 W 2.10 chs  
to the beginning corner containing One & one twentieth of an  
acre be it the same more or less and bounded by lands of said  
W Le Hillhouse and M S De Camps, and more particular known  
by plat affixed, made by H P Johnson this day  
together with all and singular the rights members, hereditaments and  
appurtenances to the said premises belonging, or in anywise inci-  
dent or appertaining. To have and to hold all and singular the  
said premises before mentioned unto the said M S De Camps  
his heirs and assigns forever, And I do hereby bind myself  
my heirs executors and administrators to warrant and forever  
defend all and singular the said premises unto the said M S  
De Camps his heirs and assigns, against myself and my heirs  
and every other person lawfully claiming, or to claim the same  
or any part thereof
