

on or about the 8<sup>th</sup> day of March in the year one thousand eight hundred and seventy eight did exhibit his Petition in the Court of Probate at Greenville Court House in the County of Greenville and State aforesaid against Caroline Elford Elizabeth Bostick, S J Wells, Lula H Wells and Annie Wells, and the cause being at issue before the Honorable Court aforesaid, came on to be heard on the 29<sup>th</sup> day of March One thousand eight hundred and seventy eight when the said Court, after a full Hearing thereof, and mature deliberation in the premises, did order adjudge and decree that the lot of land hereinafter mentioned, and described, should be sold at public auction by S J Douthit Probate Judge of Greenville County, on the terms, and for the purposes mentioned in the said Decretal order, as by reference thereto, on filing etc said Court, will appear; and the said S J Douthit Probate Judge as aforesaid after having duly advertised the said lot of land for twenty one days for sale by public outcry on the sixto day of May in the year of our Lord One thousand eight hundred and seventy eight did then, openly and publicly, and according to the custom of auction, sell and dispose of the said lot of land below described, unto Mrs S J Wells for One hundred and eighty Dollars, being at that price, the highest bidden for the same. Now know all men, that I, the said S J Douthit Probate Judge as aforesaid in consideration of the premises, and also in consideration of the sum of one hundred and eighty Dollars paid me by the said Mrs S J Wells, the receipt whereof is hereby acknowledged, have granted, bargained and sold and released, and by these presents do grant, bargain sell and release unto the said Mrs S J Wells and her heirs and assigns, all that piece parcel and lot of land, situate lying and being in the County of Greenville and State aforesaid, within the limits of the City of Greenville, adjoining lot of Mrs Jennie Goodwin Beginning at a stake on Laurens Street, thence N 70 1/2 E 113 ft to a stake on Buncome Street, thence S 36 1/3 E 17 1/2 ft 6 in with Buncome St to Laurens St thence N 71 1/4 E 95 ft 4 in with Laurens St to the beginning corner, and containing fifteen one hundredeths of an acre, more or less. Together with all and singular the rights, members, hereditaments and appurtenances whatsoever, to the said lot of land belonging, or in anywise appertaining, and the reverous and remainders, rents, issues and profits thereof, and also all the estate, right, title, interest, power, possession, property, benefit claim and demand whatsoever, both at law and in equity, of the said S J Wells and of all the parties to the said suit, and of all other persons rightfully claiming or to claim the same, or any part thereof, by, from or under them, or either of them, to have and to hold the said lot of land, with its hereditaments, privileges, and appurtenances unto the said Mrs S J Wells her heirs and assigns forever.
