State aforesaid (the receipt whereof is hereby acknowledged) have
granted bargained sold and released, and by these presents do grant
bargain sell and release into the said John Adams Sen a certain
piece parcel or tract of land containing One hundred and twenty
Seven Acres be the same more or less situated in Grove Township
and Greenville County in the State aforesaid on the West side of
Cedy River Beginning at Stake 3 x 3 x on by black gum bushes
on the right bank of said River thence S 50 W 18 chains to rock 3 x 3 x
on thence N 25 W 41.00 ch to rock pile 3 x 3 x on formerly a pine
3 x 3 x on gone thence S 50 W 23.50 ch to rock 3 x 3 x on by black
oak 3 x 2 each thence S 30 E 53.50 ch to rock 3 x 3 x on thence N 64 E 8.75
ch to small holly 3 x 3 x on near the fence and old line thence N 36 1/4
W 14.50 ch to small black gum 3 x 3 x on above a spring thence N 62 3/4
E 2.10 ch to bunch of small maples 3 x 3 x on on the right bank of said
