of the State & County aforesaid for and in consideration of the sum of one hundred dollars in hand paid & is to pay fifty bushels of corn every year besides the rent one third as long as I live to me in hand paid by John L Cantrell the receipt whereof is hereby acknowledged have granted bargained sold and released conveyed & confirmed and do hereby grant bargain sell and release convey and confirm unto the said John L Cantrell all that piece of land containing fifty acres more or less situated in the State and County aforesaid on Middle Saluda River joining the line Potts old place beginning on a Chestnut corner on the top of the mountain on the line of Elizabeth Johns then running the line with the Potts land to the river to Baine line then up the said river to a mark above the ford then to a worn out back of the stable then to the chestnut on the top of the mountain the beginning to have & to hold all and singular the premises with the appurtenances unto the said John L Cantrell and assigns forever and the said Perry Cantrell do hereby bind myself and my heirs and assigns to warrant and forever defend all and singular the premises together with the appurtenances unto the said John L Cantrell to have and to hold free from every other claim whatever

tion of the sum of One hundred and forty five dollars to me in hand paid and before the sealing of these presents by Mariah Harrison of Greenville County in the State aforesaid (the receipt whereof is hereby acknowledged) have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Mariah Harrison her heirs and assigns forever all that lot or parcel of land on the west side of Reddy river in the corporate limits of the City of Greenville County of Greenville and State aforesaid beginning at a stake corner on alley 20 feet wide thence S 86 1/2 W 3 chs to stake corner on street 20 feet wide thence S 79 E 2 25 chs to stake thence N 26 1/2 E 3 chs to stake thence N 79 W 2 25 chs to the beginning corner and more particularly known as part of the Spring place bounded by J M Cox lot No 4 Alley 20 ft wide and street 30 feet wide containing five eighths of an acre more or less Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining to have and to hold all and singular the said premises before mentioned unto the said Mariah Harrison her heirs and assigns forever and I do hereby bind myself my heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said Mariah Harrison her heirs and assigns against one and my heirs and every other person lawfully claiming or to claim the same or any part thereof
