by these presents do grant bargain sell and release unto the said J
Riley Ashmore a tract of land containing one hundred and fifty five acres
more or less lying in County and State aforesaid eleven miles South of Gre-
enville City in three Townships on the new land road and known as my home-
stead and more particularly described as follows beginning at Poplar Street N 46
E 2 7/8 to stake thence N 4 7/8 W 10.50 ch to stone on said Road thence N 76 E 27.17
ch rock then with W to Harris line to rock thence N 60 1/2 E 2.30 ch to mark on
ditch thence ditch line toward then S 70 1/2 W 30.50 ch rock then S 42 W 19.80
to Island Oak N 30 3/4 W 9.66 to Hickory then N 43 E 5 ch to stake
then N 26 1/4 W 16.25 ch to the beginning except a support or lifetime
interest for myself and wife Mary Ashmore which I reserve for both
of us until death. Together with all and singular the rights members
hereditaments and appurtenances to the said premises belonging or in
