Gower her heirs and assigns forever all that tract or lot of land situate lying and being in the County of Greenville and State aforesaid on both sides of the old Spartanburg Road, within the corporate limits of the City of Greenville, commencing on a Black Gum tree, thence S 85 1/2 W 5.36 to a stone tree, thence S 18 1/2 E 6.60 to stake tree, thence S 89 1/2 E 4.86 to a stake tree, thence N 27 1/2 W 4.50 to rock tree, thence N 53 1/2 W 1.80 to the beginning corner, containing three and ninety nine one hundredth acres more or less bounded by lands of the Estate of William Chree and the City of Greenville, and more particularly described on a plat made by H.
