eration of your integrity and faithful power as hereby given to you, To take
the renunciation of Mrs Keatie B West wife of E H West of Tarrant
County in the State of Texas of her dower in the premises described in the
deed from the said Keatie B West and E H West to William Roman dated
at Greenville S. C. the 16th day of December 1878 conveying a certain
lot of land situate in the County of Greenville State of South Carolina
which is divided in the annexed deed for this purpose will cause the
said Mrs Keatie B West to appear before you and you will examine
her privately and separately and apart from all other persons and if upon
such examination she shall freely declare that she does freely voluntarily
and without any compulsion dread or fear of any person or persons
whomsoever renounce release and forever relinquish to William Roman his
heirs and assigns all her interest and estate and also all her right and
claim of dower of in or to all and singular the premises described and
conveyed in the deed aforesaid. Then you shall take under her hand a
