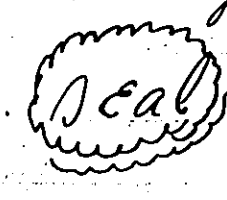

Know all men by these presents that I S J Dill in the State aforesaid, County of Greenville

in consideration of the sum of thirty Dollars to me paid by or allowed by the stock holders of Tigerville Academy in the State aforesaid, Greenville Co. have granted bargained sold and released, and by these presents do grant bargain sell and release unto the said stockholders their representatives or Trustees for said Academy (or their successors in office for said Academy) a certain piece parcel or lot of land lying on East side State road; running as follows. - Beginning on a stake in State road corner of G W Pedglers thence South 1 1/2 East two chains (2 ch 50 L) and fifty links to a stake in State road thence North eighty (80 L) and three fourth East six chains nineteen links (6 ch 19 L) to a stone 4 x 3 three North forty (40) West two chains (2 ch 70 L) seventy links - to a stone (3 x 7) South eighty (80 1/4) three fourth West four chains (4 ch 63 L) sixty three links to the beginning containing One Acre (1 1/100) four tenths more or less Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining: To have and to hold all and singular the premises before mentioned unto the said stockholders or their Trustees and successors heirs and assigns forever, And I do hereby bind myself heirs executors and administrators, to warrant and forever defend all and singular the said premises unto the said stockholders or their Trustees and successors for educational purposes heirs and assigns against me and my heirs lawfully claiming or to claim the same, or any part thereof.
