County of Greenville and State aforesaid for and in consideration of the sum of Three thousand Dollars to me paid by John J Stokes as Trustee of Mrs Abigail M Stokes of the County and State aforesaid, have granted, bargained, sold and released, and by these presents do grant bargain, sell and release unto the said John J Stokes, as trustee as aforesaid, all those certain tracts, pieces and parcels of lands, situate lying and being in the County of Greenville and State aforesaid, on Beaverdam and Mountain Creeks, waters of Saluda River, Beginning on a Post - Oak near the School - house at Osthuda Church, running N 76 E 27 chs, to a stone & III (at this point I give and Deed several acres to Church); thence S 10 W 56 ch to a stone 8 x 11 1/2, adjoining to lands now belonging to W B Darby, J H Stokes, J W M Chellough, John Kerley and others, assumed to the beginning corner, containing six hundred and seven acres more or less, as will more fully appear, by reference to a large plat surveyed and made by W A Hudson, also and adjoining the above lands I bargain sell and release unto the said John J Stokes Trustee Beginning on a Red Oak on the side of the public road & III thence N 54 1/4 W 7.25 compass reversed, to a stone & III thence along the public road to a stone & III 7.00 lying on Beaverdam and Mountain Creek, containing twenty five acres more or less, as fully represented by the aforesaid survey and plat. Together with all and singular the rights, members hereditaments and appurtenances to said premises belonging or in anywise incident or appertaining. To have and to hold all and singular the premises before mentioned unto the said John J Stokes as trustee of Mrs Abigail M Stokes for her separate and exclusive use and benefit of the said Mrs Abigail M Stokes during her natural life, free from any liability for her debts or contracts, and after her death, the whole of said lands and premises to go to her lawful issue living at her death, in fee simple, to the said issue.
