release and convey unto the said S.M. Meares his heirs
executors, assigns or administrators, [all that tract or
parcel of land lying, situated and being in the County of
Greenville and State of South Carolina adjoining lands
of John Peden, Wm. Chores and others, and more particular-
ly described as follows, to wit: Beginning at a stake on the
East bank of Reedy River, thence N 86 E 23.50 to Hickory 3x
down now stone, thence N 1/4 E 9.50 to O 3x 10 m now stone
thence S 68 E 44.65 to W O 3x 0 m thence N 4.68 to stone 3x
0 m thence N 86 W 9.00 to stake 3x 0 m thence N 10.00 to
stake 3x 0 m thence N 87 W 32.35 to stake 3x 0 m thence S 80.00
to stake 3x 0 m thence S 88 W 30.25 to stake 3x 0 m on River bank
thence down meanderings of said River to point of begin-
ning containing One hundred and eighty acres, more or
less, Together with all and singular the right members
